Liability Waiver & Release Form

ALL PARTICIPANTS MUST COMPLETE & SIGN THIS WAIVER & RELEASE FORM

This Liability Waiver & Release Form ("Release") is entered into voluntarily between **Colorado Land Cruisers** ("CLC"; the "Club") and the undersigned **Participant** (hereafter "I", "me", or "my").

I desire to participate in four wheeling/4X4/off-roading (hereafter 4X4) activities with CLC. I understand that signing this Waiver is a requirement for CLC membership, or to participate with the Club in 4X4 and related activities, either as a member or a guest. **Guests and members under the age of 18 are not permitted to participate as a driver.**

Waiver and Release: I release, forever discharge, and hold harmless CLC, its leaders, members, and their families, friends, associates, guests, and successors (collectively "CLC" hereafter), from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise, from my participation in Club activities. I understand and acknowledge that this Release discharges CLC from any liability or claim that I may have against CLC with respect to bodily injury, personal injury, illness, death, or property damage that may result from my participation.

1. **Assumption of Risk:** I understand that participation carries inherent risks, and may include activities that require physical labor, transportation, or include circumstances that may result in personal injuries and/or vehicle/property damage. I hereby assume all responsibility for any and all risk of injury, harm, or damage that I or my vehicle may sustain while participating in any Club activity, and I release CLC from all liability.
2. **Medical Treatment:** I hereby release and forever discharge CLC from any claim whatsoever which arises or may hereafter arise on account of any first-aid, treatment, or other medical services rendered in connection with my volunteer activities.
3. **Vehicle Preparation:** I certify that I have inspected my vehicle and that it is in good mechanical condition, and that all occupants of my vehicle have and will use, at all times while participating in a CLC event, an appropriate seat belt.
4. **Insurance:** I certify that I have valid Vehicle/Medical Insurance that meets or exceeds Colorado minimums for myself and all my vehicle occupants. I understand and agree that CLC carries no insurance of any kind, and assumes no responsibility or obligation to provide me with any assistance, financial or otherwise, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of CLC.
5. **Other:** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this Release shall be governed by and interpreted in accordance with the laws of the State of Colorado. I agree that in the event any clause or provision of this Release is deemed invalid, the remaining provisions shall remain in full force and effect.
